Describe Plans for the Tournament:

Application Deadlines: For Tournaments scheduled for January, February or March, applications must be received by June 30 of the year preceding the tournament. This would include the Jack and Jill Pool Tournament, and for planning purposes, the Golf Tournament. All other Tournament applications must be received by November 15 of the preceding year to be considered. These dates are requested as to provide the committee time to make a recommendation to the Florida Moose Association Executive Board and get their approval. Any Tournament that does not have a lodge request to host may still be schedule outside of the timeline listed above.

Participants: Each participant must show active membership card to play in the tournament. Cards will be checked at registration each day of the tournament. If a nonmember wishes to participate, they must apply to be a member of the Moose and receive their membership card in order to play. Digital membership cards will be accepted with valid ID. As we are a family fraternity and our events take place in the daylight hours, children and grand children are allowed to participate as long as the sponsoring member accompanies the child. Each participant shall complete a registration form, sign the release of liability form, and the release of photo/publicity form to participate. Host Lodge is responsible to schedule volunteers to man the registration table during the tournament.

The Host Lodge must be in good standing with the Florida Moose Association and Moose International in order to participate in sporting events. Pool and Dart Tournaments have different requirements Please review those requirements prior to placing your bid.

Bid Fees: Each Lodge Bid which is approved and accepted by the Florida Moose Association is required to submit the bid fee by January 15 of the year the Tournament is to be held. Failure to do so will could forfeit the tournament bid and it may be awarded to the runner up Bid. Currently the bid fee is set at \$100 however , to cover rising costs it could be higher. If your tournament requires a committee coordinator to run the tournament, the hosting lodge would be required to provide accommodations to the coordinator.

Schedule of returning Tournaments:

Men's 8 Ball State Tournament is held on labor Day Week Weekend each year.

Men's Regional 8 Ball Tournament are held in the Spring

Women's 8 Ball Tournament is held in July

Mixed Doubles (Jack and Jill) Tournament held in February

Golf is held the second weekend of June

Horseshoes is held in October/November

Soft Tip Darts held in August

Tournaments not listed will be scheduled at the Coordinators and Lodge's Discretion
